AN ORDINANCE IMPOSING A SIX (6) CENT LOCAL OPTION FUEL TAX UPON EVERY GALLON OF MOTOR FUEL AND SPECIAL FUEL SOLD IN HAMILTON COUNTY, FLORIDA, AND TAXED UNDER THE PROVISION OF CHAPTER 206, FLORIDA STATUTES; PROVIDING THAT THE IMPOSITION SHALL BE EFFECTIVE FOR A TERM TO COMMENCE JANUARY 1, 2021, AND EXPIRE DECEMBER 31, 2022; PROVIDING FOR DISTRIBUTION BETWEEN HAMILTON COUNTY AND ALL OF THE MUNICIPALITIES IN HAMILTON COUNTY, FLORIDA, IN ACCORDANCE WITH THE PROVISIONS OF SECTION 336.025, FLORIDA STATUTES; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; AND, PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Hamilton County, Florida, on August 7, 2018 adopted Ordinance No. 2018-04, providing for a six (6) cent local option fuel tax upon every gallon of motor fuel and special fuel sold in Hamilton County, Florida, and taxed under the provisions of Chapter 206, Florida Statutes, for the term from January 1, 2019 to December 31, 2020; and, in connection with said Ordinance No. 2018-04, Interlocal Agreements were entered into between said County and all of the incorporated municipalities in said County in accordance with the provisions of Section 336.025, Florida Statutes; and

WHEREAS, said Ordinance No. 2018-04 will expire on December 31, 2020; and

WHEREAS, the Board of County Commissioners desires to impose said tax for the term commencing January 1, 2021, and to be in force and effect until December 31, 2022; now, therefore, the premises considered, be it

ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HAMILTON COUNTY, FLORIDA, that:

- Section 1. This Ordinance is authorized by, and adopted pursuant to, Section 336.025, Florida Statues, and other applicable law.
- Section 2. There is hereby imposed a six (6) cent local option fuel tax upon every gallon of motor fuel and special fuel sold in Hamilton County and taxed under the provisions of Chapter 206, Florida Statutes.
- Section 3. The tax imposition hereby shall be effective for a term to commence January 1, 2021 and expire December 31, 2022.
- Section 4. The tax imposed hereby shall be collected and distributed in accordance with the procedures set forth in Section 336.025(2), Florida Statutes.
- Section 5. After deductions of all fees or charges made by the State of Florida or any of its agencies, the proceeds of the local option fuel tax hereby imposed shall be divided among, and distributed to, Hamilton County and the municipalities within Hamilton County in accordance with the provisions of Section 336.025, Florida Statutes.
- <u>Section 6.</u> All ordinances or parts of ordinances in conflict with the provisions contained herein are hereby repealed.
- Section 7. If any section, subsection, sentence, clause, provision or part of this Ordinance shall be held invalid for any reason, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.
- Section 8. In accordance with Section 125.66 Florida Statutes, a certified copy of this Ordinance, as enacted, shall be filed by the Clerk of this Board with the Department of State of the State of Florida within 10 days after enactment by said Board and shall take effect upon filing with the Department of State.
