TOWN CHARTER

Article II. Legislative.

Section ~~2.01~~ **Compositions, Eligibility, Requirements.**

- (a) Composition. There shall be a Town Council composed of five (5) members elected at large by the qualified voters of the Town.
- (b) Eligibility. In order to be eligible to qualify for the office of Council Member, the individual must meet the following criteria:
 - 1. Candidates for office shall have been duly registered voters in Hamilton County and must physically reside in the Town of White Springs for twelve (12) months immediately preceding qualifying.
 - 2. Any person who has been currently deprived of his civil rights through conviction for committing a crime involving a felony or ~~moral turpitude shall not be qualified to hold office.~~

Section 2.03 Vacancies; Forfeiture of Office; Filling of Vacancies and Extraordinary Vacancies

- (a) Vacancies. A Town Council member ~~shall forfeit~~ his office if he:
 - 1. ~~intentionally misrepresented facts which were used to determine his eligibility for election to office~~
 - 2. ~~Willfully violates any express prohibition of this Charter~~
 - 3. Is convicted of a crime involving felony or ~~moral turpitude.~~
 - 4. Fails to attend three (3) Consecutive regular meetings of the council without the Council's approval.
 - 5. ~~Moves his residence from the Town of White Springs~~
 - 6. ~~For malfeasance, misfeasance or non-feasance in office~~
 - 7. When the Town Council determines by majority vote that there is reasonable cause to believe that any Council Member is disabled so as to be unable to perform his duties, such member may be compelled to submit

to medical examination by a physician of his choice, who shall render a written evaluation of such member to the Town Council. The physician's evaluation must indicate, with reasonable medical certainty, whether or not the Council Member will be able to perform his duties for a period in excess of three (3) months. A Council Member evaluated to be unable to perform his duties shall be declared to be disabled, and forfeit his office as herein provided, without his voluntary consent.

8. ~~The Council, upon majority vote, shall notify the affected Council Member in writing of its intent to declare the seat forfeited for any of the reasons referenced above. The affected Council Member shall have seven (7) days from the receipt of notice to provide the Clerk with a written request for a hearing before the Council for the purpose of providing evidence in opposition to the Council's intended action.~~ If the evidence presented is insufficient to overcome the identified reasons for forfeiture, the Council may declare the seat forfeited and vacant in which case the decision may be appealed to the circuit court.

Section 2.04 Investigation.

~~The Council, by majority vote, and showing good cause, may make investigation into the affairs of the Town and the conduct of any Town Department, Office or Agency and for this purpose may hold hearings, take testimony, and require the production of evidence. These and all other investigations shall comply with State and Federal Statutes.~~

Section 3.02 Powers and Duties of the Town Manager.

The Town Manager shall be the chief administrative officer of the Town, responsible to the Council for the administration of all Town affairs placed in the Manager's charge by or under this Charter. The Town Manager shall:

- (a) ~~Appoint and, when he deems it necessary for the good of the Town, suspend or remove the Town employees and appointed administrative officers provided for by or under this Charter, except as otherwise provided by law, this Charter or personnel rules adopted pursuant to this Charter. He may authorize any administrative officers who are subject to his direction and supervision to exercise these powers with respect to subordinates in that officer's department, office or agency.~~
- (b) Direct and supervise the administration of all departments, offices and agencies of the Town, except otherwise provided by this Charter or by law;

Section 9.08 Recall.

~~The qualified electors shall have the power to recall and to remove from office any elected official of the municipality as provided by general law or by the provisions of this Charter.~~

Section 10.02 Prohibitions

- (a) Discrimination against any person in recruitment, examination, appointment, training, promotion, or any other personnel action due to political or religious opinion or affliction, or because of race, sex, national origin, age, physical handicap, or any other non-merit factor is prohibited.
- (b) No person shall willfully make any false statement certificate, mark, rating, or report in regard to any test, certification or appointment under the personnel provision of this Charter, or the rules and regulations made there under or any ordinance or in any manner commit or attempt to commit any fraud preventing the impartial execution of such provisions, rules and regulations.
- (e) Penalties. Any person who violates the provisions of this section shall forfeit his or her office or position.

FIRST READING NOTICE

ORDINANCE NO. 2023-01

AN ORDINANCE OF THE TOWN OF WHITE SPRINGS, FLORIDA, PERMANENTLY VACATING AN UNOPENED PORTION OF WESSON STREET, A ROAD WITHIN THE TOWN'S ROAD SYSTEM, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 2.06 of the Town Charter and Florida Statutes sections 166.021 and 334.03, the Town Council of the Town of White Springs is an incorporated municipality with jurisdiction over the city street system within the town; and

WHEREAS, the Town Council, at the request of Adrienne Sachse, wishes to vacate an unopened portion of WESSON STREET lying north of Jewett Street and south of Collins Street.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WHITE SPRINGS, FLORIDA, THAT:

Section 1. RECITALS:

The recitals above are true and correct and are incorporated by reference.

Section 2. UNOPENED STREET VACATED

The extent of WESSON STREET lying north of Jewett Street and south of Collins Street is hereby vacated, abandoned and closed, and shall no longer constitute a part of the Town's road system.

Section 3. LANDS RETURNED TO PRIVATE PROPERTY

As provided by Florida Law, the real property previously encumbered by the vacated right of way is returned to private property, with the road divided at its center line and the right of way becoming parts of the parcels adjoining the respective halves.

Section 4. CONFLICTS:

All Ordinances or parts of Ordinances and all sections or parts of sections of any Ordinance or the Code of Ordinances of the Town of White Springs, Florida in conflict with this Ordinance are hereby repealed.

Section 5. SEVERABILITY:

In the event any section, paragraph, sentence or clause or portion of this Ordinance shall for any reason be held unconstitutional, invalid, or ineffective, the same shall not repeal, nullify, or in any wise affect any other section, paragraph, sentence or portion of this Ordinance. The Town Council of the Town hereby declares that it would have enacted each separate section, paragraph, sentence, clause and portion of this Ordinance irrespective of any other section, paragraph, sentence, clause and portion of this Ordinance.

Section 6. EFFECTIVE DATE:

This Ordinance shall take effect immediately upon its adoption by the Town of White Springs, Florida in accordance with the provisions of Florida Statutes.

ORDINANCE NO. 2023-02

AN ORDINANCE OF THE TOWN OF WHITE SPRINGS, FLORIDA, PROHIBITING SMOKING AND VAPING IN PUBLIC PARKS WITHIN THE TOWN OF WHITE SPRINGS, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, tobacco use causes death and disease and continues to be an urgent public health threat, as evidenced by the following:

1. The World Health Organization (WHO) estimates that tobacco kills up to half of its users, amounting to more than 8 million deaths each year worldwide, including nearly half a million people who die prematurely from smoking in the United States alone¹;
2. Tobacco use causes disease in nearly all organ systems and is responsible for an estimated 87% of lung cancer deaths, 32% of coronary heart disease deaths, and 79% of all chronic obstructive pulmonary disease deaths in the United States²;
3. The estimated economic damage attributable to smoking and exposure to secondhand smoke in the United States is nearly \$300 billion annually³;
4. Despite significant progress, tobacco use remains the leading cause of preventable death and disease in the United States⁴;
5. Specifically, in Florida, 29.4% of cancer related deaths are attributable to smoking⁵.
6. Electronic vapor products have been found to contain nicotine, lead, formaldehyde, and thousands of other chemicals. These products damage DNA and harm parts of the brain responsible for learning and mental health⁶.

WHEREAS, secondhand smoke exposure is harmful and widespread, as evidenced by the following:

1. Children exposed to secondhand tobacco smoke have an increased risk of sudden infant death syndrome, asthma, physical and cognitive developmental abnormalities, and cancer;
2. The 2006 U.S. Surgeon General's report, "The Health Consequences of Involuntary Exposure to Tobacco Smoke," concluded that there is no safe level of exposure to secondhand smoke;
3. The World Health Organization in 2007 declared that there is indisputable evidence that implementing 100% smoke-free environments is the only effective way to protect the population from the harmful effects of exposure to secondhand smoke;
4. In Florida, 59% of children between ages 11 and 17 report being exposed to secondhand smoke from cigarettes or electronic vapor products;

WHEREAS, there is emerging evidence that exposure to the aerosol produced by a vapor-generating electronic device may be harmful, as evidenced by the following:

1. E-cigarettes produce an aerosol that contains at least ten chemicals known to cause cancer, birth defects, or other reproductive harm.⁷
2. Bystanders exposed to e-cigarette aerosol can also absorb its nicotine.⁸
3. The aerosol is made up of a high concentration of ultrafine particles, and the particle concentration is higher than in conventional tobacco cigarette smoke.⁹
4. Exposure to fine and ultrafine particles may exacerbate respiratory ailments like asthma and constrict arteries which could trigger a heart attack.¹⁰

WHEREAS, tobacco waste is a major, consequential, and persistent source of litter, as evidenced by the following:

1. The roughly 6.3 trillion cigarettes smoked globally each year result in 300 billion packs that produce almost 2 million tons of wastepaper, cellophane, foil, and glue as well as trillions of butts littered across roadways, sidewalks, parks, and other green spaces¹¹;¹²
2. Both tobacco industry and peer-reviewed research found that most smokers admit littering their cigarette butts¹³,^{53,54} for example, one study found 74.1% of smokers admitted littering cigarette butts at least once in their life and 55.7% admitted to littering them in the past month¹⁴;
3. In an observational study of nearly 10,000 individuals, 65% of smokers disposed of their cigarette butts as litter¹⁵;
4. Cigarette butts are perennially the most common form of litter collected during cleanup programs worldwide. For example, in 2018, cigarette butts made up nearly 16% of all litter collected through cleanup programs in the U.S. (809,538 out of 5,106,515 items)
5. Cigarette butts are often cast onto sidewalks and streets, and frequently end up in storm drains that flow into streams, rivers, bays, lagoons, and ultimately the ocean¹⁶;
6. As of August 2019, the U.S. Environmental Protection Agency recognizes nicotine- containing electronic smoking devices as acute hazardous waste when disposed properly¹⁷;

WHEREAS, cigarette butts, smokeless tobacco, and electronic smoking devices pose a health threat of poisoning to young children, as evidenced by the following:

1. In 2018, American poison control centers logged nearly 13,000 cases involving exposure to cigarettes, cigarette butts, electronic smoking devices, or other tobacco products, and of these, more than 10,000 (79.0%) occurred in children aged 5 years and younger¹⁸;
2. Among the 10,266 cases of nicotine and tobacco product exposure recorded in 2018 among children 5 years of age and younger by American poison control centers, 50.3% involved cigarettes, 18.4% involved electronic smoking devices, and 8.0% involved other tobacco products¹⁹;
3. The annual number of electronic cigarette exposure cases among children less than 5 years of age reported to American poison control centers increased from 10 in 2010 to 1,835 in 2018, a 14,015% increase²⁰; and
4. Children who ingest tobacco products can experience vomiting, nausea, lethargy, and gagging, with e-liquids potentially posing a greater risk of toxicity or fatality through either ingestion or transdermal absorption²¹;

WHEREAS, Florida cities and counties have the legal authority to adopt local laws that prohibit smoking in public parks.

NOW THEREFORE, in order to provide for the public health, safety, and welfare, reduce unwanted and unwelcome exposure to secondhand smoke, assure cleaner and more hygienic parks for the Town of White Springs, its residents, and visitors, it is the intent of the Town Council, in enacting this ordinance, to prohibit smoking and vaping in parks which are used by or open to the public and to prohibit smoking and vaping waste in those areas thereby affirming and promoting a healthy environment in the Town of White Springs.

Section 1. RECITALS INCORPORATED. The above recitals are incorporated herein.

Section 2. DEFINITIONS. The following words and phrases, whenever used in

this part shall have the meanings defined in this section unless the context clearly requires otherwise:

- (a) "Electronic Smoking Device" means an electronic device that may be used to deliver any aerosolized or vaporized substance to the person inhaling from the device, including, but not limited to, an e-cigarette, e-cigar, e-pipe, vape pen, or e-hookah.
- (b) "Park" means all public property specifically designated as being used for outdoor recreational or park purposes and where children regularly congregate. "Outdoor recreational or park purposes" includes, but is not limited to, boating, golfing, camping, swimming, horseback riding, and archaeological, scenic, or scientific sites and applies only to land which is open to the general public.
- (c) "Smoking" means inhaling, exhaling, burning, carrying, or possessing any lighted tobacco product, including cigarettes, filtered cigars, pipe tobacco, and any other lighted tobacco product whether natural or synthetic. "Smoking" also means using an electronic smoking device or any other plant product intended for inhalation, including hookah and marijuana. For the purposes of this policy only, smoking does not include the use of unfiltered cigars (pursuant to Florida Statute 386.209).
- (d) "Tobacco Product" means:
 - (1) any product containing, made, or derived from tobacco, nicotine or nicotine analogues that is intended for human consumption or is likely to be consumed, whether inhaled, absorbed, or ingested by any other means, including but not limited to, a cigarette, a cigar, pipe tobacco, chewing tobacco, snuff, or snus;
 - (2) any electronic smoking device as defined in this [article/chapter] and any substances that may be aerosolized or vaporized by such device, whether or not the substance contains nicotine; or
 - (3) any component, part, accessory, of (1) or (2), whether or not any of these contains tobacco or nicotine, including but not limited to filters, rolling papers, blunt or hemp wraps, hookahs, and pipes."Tobacco Product" does not mean drugs, devices, or combination products authorized for sale by the U.S. Food and Drug Administration, as those terms are defined in the Federal Food, Drug, and Cosmetic Act.
- (e) "Tobacco Product Waste" means any material that is left over and regularly intended to be discarded after the use or consumption of a tobacco product. Tobacco Product Waste includes, but is not limited to, discarded cigarette butt filters, cigar or cigarillo tips, cigarette packs, cigar or cigarillo wrappers, electronic smoking devices of all types, electronic smoking device cartridges

or refill containers, plastic packaging, foil, or other disposable tobacco product remnants or tobacco product packaging in any form.

- (f) "Vaping" means the inhaling, exhaling, or holding of an activated electronic smoking device.

Section 3. PROHIBITION OF TOBACCO USE IN RECREATIONAL AREAS.

Smoking and the use of all other tobacco products is prohibited in all parks within the incorporated limits of the Town of White Springs, Florida. Unfiltered cigars are exempted under 386.209, Florida Statutes.

Section 4. OTHER REQUIREMENTS AND PROHIBITIONS.

- (a) No person shall dispose of tobacco product waste in any park.
- (b) The Town Manager or their designee shall post at least one clear, conspicuous and unambiguous "No Smoking or Vaping" sign at each point of ingress to the area, and in at least one other conspicuous location where individuals congregate (such as restrooms, playgrounds, or buildings) within each recreational area. For purposes of this section, the Town Manager or their designee shall be responsible for the posting of signs in regulated facilities owned or leased in whole or in part by the Town. Notwithstanding this provision, the presence or absence of signs shall not be a defense to a charge of smoking in violation of any other provision of this ordinance.

Section 5. COMPLIANCE AND ENFORCEMENT. The success of this policy depends on the consideration and cooperation of both tobacco-users and non-users. Individuals acting in violation of this policy will be reminded and asked to comply. Individuals who violate this policy may be asked to leave the park. Enforcement and fines for violation of this section shall be in accordance with general law.

Section 6. STATUTORY CONSTRUCTION & SEVERABILITY. If any section, subsection or provision of this ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections or provisions of this ordinance or its application to any other person or circumstance. The Town Council hereby declares that it would have adopted each section, subsection or provision hereof independently, irrespective of

the fact that any one or more other sections, subsections or provisions hereof be declared invalid or unenforceable.

Section 7. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its adoption by the Town of White Springs, Florida in accordance with the provisions of Florida Statutes.

FIRST READING NOTICE**

ORDINANCE NO. 2023-03

AN ORDINANCE OF THE TOWN OF WHITE SPRINGS, FLORIDA, INCREASING USAGE RATES FOR WATER AND WASTEWATER PROVIDED BY THE TOWN'S UTILITIES AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of White Springs operates potable water and wastewater/sewer utilities serving residential and commercial properties within the utility service area and charges connection and usage fees in connection with such services;

WHEREAS, the Town commissioned a Rate Study (the "study") from the Florida Rural Water Association ("FRWA") to assess the Town's current rates and fees and the viability of the utility going forward;

WHEREAS, according to the study, FRWA determined that at current rates the Town's utilities will operate at revenue deficits, meaning the utilities will cost more to run than they return to the Town;

WHEREAS, revenue deficits will increase each year if no adjustments are made to existing rates;

WHEREAS, the study notes that "EPA recommends that water and wastewater systems set rates to ensure that there are enough revenues in place to support the costs of doing business" and that cost includes consideration of unanticipated expenses like future repairs, replacements, and maintenance to the systems;

WHEREAS, FRWA "recommends an adjusted rate structure that is both fair and equitable and increases classifications to better fit [the Town's] system's needs" and "that the rates classification be expanded into two categories: 1) Residential, 2) Commercial";

WHEREAS, FRWA also recommended that "the new rate schedule be evaluated annually to ensure it supports the current year budget";

WHEREAS, the Town's utility rates have not been adjusted in some time, such

that rates have not kept pace with the increasing cost to operate and maintain the utility;

WHEREAS, the avoid an exorbitant increase in any given year, FRWA has recommended a gradual increase approach to be implemented over five fiscal years; and

WHEREAS, it is in the Town’s best interest and the interest of the health, safety and welfare of the customers of the Town that the usage rates for utility services be increased according to the recommendations of FRWA.

NOW, THEREFORE, be it ordained by the Town Council for the Town of White Springs, Florida.

Section 1. RECITALS INCORPORATED. The above recitals are incorporated herein.

Section 2. NOTICE GIVEN. Notice of the consideration and adoption of this Ordinance has been given via the Town’s utility billing system as required by Florida Statutes section 180.136.

Section 3. RATES ADOPTED. Pursuant to the recommendations of the Florida Rural Water Association and the study, the following rates shall be charged for use of the Town’s water and wastewater systems.
