To my fellow Council members:

I, the Honorable Mayor Anita T. Rivers would like to call for a vote to remove Councilwoman Nicole Williams for a lack of confidence as she is not acting in the best interest of the town's people who elected her and this council. Councilwoman (Nicole) Williams has lied to this council. My first complaint is when Ms. (Nicole) Williams made a call to 911 call during the February 14, 2023 council meeting requesting an officer. As with most meetings, there were two officers present at the time of her phone call. In fact, the 911 operator told her that there should be officers present at the meeting, which she confirmed. She continued to ask for additional officers despite the 911 operator insisting that there was an officer on site and to discuss with them. He discontinued the call.

However, what really disturbed me is a comment made while on the call with 911. Ms. (Nicole) Williams can be heard stating, "Anita them going down for this", and Ms. (Nicole) Williams stated to 911 that Jacqueline Williams, Mary Berry, and I were "crooked". I perceive these statements as threats not only to our reputations but to how we do business as well. Ms. (Nicole) has created a hostile work environment for the town and specifically the council.

In addition, Ms. (Nicole) Williams has accused this council of raising the town's water rates without proof and why. Ms. (Nicole) Williams know that this is not true and can be proven with the minutes from previous meetings. Florida Rural Water Association's Andrew Greene conducted a water study August 5, 2022. This study gave a ten year break down on how much the town should charge for water and sewer. This issue was discussed in regular council meetings and budget meetings. As stated previously, this can be proven and Ms. (Nicole) Williams voted in favor of both raising the water rates and the town's budget.

In section 2.03 of the town's Charter, it gives several reasons for removal or forfeiture from office. Based on what I have presented in this letter, Ms.(Nicole) Williams has made false statements and has committed both malfeasance and misfeasance. Therefore, I recommend her removal from the council immediately as time permits.

Section 2.03 Vacancies; Forfeiture of Office; Filling of Vacancies and Extraordinary Vacancies

- (a) Vacancies. A Town Council member shall forfeit his office if he:
 - 1. Intentionally misrepresented facts which were used to determine his eligibility for election to office.
 - 2. Willfully violates any express prohibition of this Charter.
 - 3. Is convicted of a crime involving felony or moral turpitude.
 - 4. Fails to attend three (3) Consecutive regular meetings of the council without the Council's approval.
 - 5. Moves his residence from the Town of White Springs 6. For malfeasance, misfeasance or non-feasance in office.
 - 7. When the Town Council determines by majority vote that there is reasonable cause to believe that any Council Member is disables so as to be unable to perform his duties, such member may be compelled to submit to medical examination by a physician of his choice, who shall render a written evaluation of such member to the Town Council. The physician's evaluation must indicate, with reasonable medical certainty, whether or not the Council Member will be able to perform his duties for a period in excess of three (3) months. A Council Member evaluated to be unable to perform his duties shall be declared to be disabled, and forfeit his office as herein provided, without his voluntary consent.
 - 8. The Council, upon majority vote note, shall notify the affected Council Member in writing of its intent to declare the seat forfeited for any of the reasons referenced above. The affected Council Member shall have seven (7) days from the receipt of notice to provide the Clerk with a written request for a hearing before the Council for the purpose of providing evidence in opposition to the Council's intended action. If the evidence presented is insufficient to overcome the identified reasons for forfeiture, the Council may declare the seat forfeited and vacant in which case the decision may be appealed to the circuit court.
